Houston Controller's Office Earns National Honor for Opening City Finances to Residents

HOUSTON —For the first time, Houstonians can see a clear snapshot of the City's finances in plain language—and it's already earned national recognition.

The <u>City of Houston Controller's Office</u> has received the *Award for Outstanding Achievement in Popular Annual Financial Reporting* from the Government Finance Officers Association (GFOA). The award recognizes Houston's inaugural *Popular Annual Financial Report* (PAFR), which breaks down the City's fiscal year ending June 30, 2024, in a way that's accessible and easy to understand.

"This recognition affirms one of the priorities of my office – to put Houstonians at the center of City finances. Numbers alone don't make government accountable. People do. By making this information open and easy to understand, we're helping Houstonians hold their government to a higher standard. That's the kind of transparency our city deserves," said City Controller Chris Hollins.

The PAFR simplifies complex financial data into an easy-to-read format, giving residents a straightforward look at the City's financial position—without the jargon of traditional reports.

Houston also earned GFOA's *Certificate of Achievement for Excellence in Financial Reporting* for its Annual Comprehensive Financial Report. Reports are evaluated by an independent panel for clarity, creativity, distribution, reader appeal, and overall quality.

"This report is about more than numbers on a page. It's about trust. For the first time, Houstonians can open a City report and actually see, in plain English, where their money is going. That matters because transparency and accountability work together to build a stronger Houston."
