Community members are welcome to participate and connect with neighbors in support of Houston's spirit of unity. Meals will also be delivered to residents of Cuney Homes, a historic public housing development in Third Ward.

"The holidays remind us how important it is to show up for one another," said Houston City Controller Chris Hollins. "Through partnership and neighborly support, we're helping Houston families gather, give thanks, and look ahead with hope."

"Community is built around the table—through shared experiences, compassion, and connection," said Kashala T. Pope, Executive Director of the Houston Texans YMCA.
