Status

- Regional PIO Forum (HHD, HCPH, Fort Bend) meets at least monthly with escalation during public health emergencies
- Local Health Authorities (LHAs) meet every month to discuss current data, public health issues affecting the region, and specific messages that need to be amplified
- Joint communications deployed during 2025 West Texas measles outbreak (common list of immunization locations) for additional awareness
- Joint disaster communications: Hurricane Beryl 2024

Strong ties across clinical teams







Complementary approaches and clear referral pathways in place

Initial ILA Goals	Collaboration Examples (subset only)
Collaboration for clinical and preventative health care	 Clear, complementary roles established for HIV: HHD administers CDC HIV prevention grants, while HCPH administers Ryan White Part A HIV treatment and care funds; co-authored Ending the HIV Epidemic (EHE) Master Plan for Houston / Harris County Cross-jurisdictional TB case management with HHD, HCPH, and DSHS Shared outreach, referral pathways, and case coordination for prenatal and postnatal care through Healthy Start HCPH Chronic Disease Prevention services offered at MSCs and parks Collaboration to increase vaccine uptake across city and county
	 <u>Next Steps:</u> Begin mobile dental services at Hiram Clarke (November 2025) and Third Ward MSC (March 2026); optimize mobile health locations

Collaboration extends beyond ILA







Ongoing communication & coordination strengthens overall approach

Selected coordination examples - not exhaustive!

- Environmental Public Health collaboration during legislative session on food permitting advocacy; aligned approach to developing new collaborative agreements with DSHS for ongoing inspections
- "Single provider" services, such as HHD providing all rabies testing or HCPH Mosquito & Vector Control serving entire county (upcoming ILA with HPARD on mosquito, tick, and avian surveillance in city parks), and "no wrong door" approaches like County Pets wellness services
- Emerging collaboration on violence prevention and reentry services, including HCPH violence interruption teams in Sunnyside and at Ben Taub, partnership with HHD violence prevention staff and CBOs funded through COH at HCPH Violence Prevention Conference, initial efforts to access HPD data
- "Surge support" for large disease outbreak or foodborne illness investigations
- Aligned pet registration requirements and costs across HCPH County Pets and BARC
- Joint advocacy efforts on regional and Texas related public health legislation through work in TACCHO

Emerging aspirations; new opportunities









Deeper collaboration required amidst funding constraints

Revenue diversification

- Philanthropic funding
- Management district & TIRZ agreements
- Shared savings models ("Prevention as a Service")
- Reimbursement for non-medical drivers of health (NMDoH) support

Technology transformation

- Harris Health "Back to Foundation" EPIC journey including public health modules
- Increased use of technology to improve patient experience

Expanded legislative engagement

- Preserving funding remains paramount
- · Bipartisan support needed for public health fundamentals like immunization

Secure funding

- Local budgets
- State and federal advocacy
- Connection to philanthropic sources and private partners

Amplify messaging

- Ensure communications teams are connected
- Promote healthy behaviors and health department resources
