

CODE MODERNIZATION: HISTORY

The most recent 2021 code adoption was performed in 2024. This grant funded program aimed to update the City's dated construction codes and modernize its code development process.

- Process spanned almost two years
- Involved stakeholder engagement, task force groups, and committee reviews
- Hosted internal and external code training workshops
- Successfully adopted the 2021 International Building Codes in 2024





CODE ADOPTION: HIGHLIGHTS

FOR THE 2021 CODE ADOPTION EFFECTIVE JANUARY 1, 2024



Achieved the fastest code adoption in the history of the City of Houston.



TRAINING TOOLKIT

Created:

- 26 Technical Papers to provide a clearer definition and description of the codes.
- 2,700+ pages of Cross Reference Code Analyses for 7 codes.
- 1,000 slides of Significant Changes for 9 Building Codes.



TRAINING COURSES

Provided to community stakeholders and Houston Permitting employees:

- 130 education hours
- 65+ trainings & workshops
- 1000+ community stakeholder participants
- 230 Houston Permitting Center participants




TRAINING MANUAL


- Houston Permitting Center staff and industry professionals
