II. Public Services

- a. The Housing and Community Development Department (HCD) recommends Council approval of an Ordinance authorizing a Subrecipient Agreement between the City of Houston (City) and **Access Care of Coastal Texas, Inc.** (ACCT) providing \$1,276,825.00 in Housing Opportunities for Persons with AIDS (HOPWA) funds to serve 149 low-to moderate-income (LMI) households living with HIV/AIDS. (All Districts)
- b. HCD recommends Council approval of an Ordinance authorizing a Second Amendment to the Subrecipient Agreement between the City and **Catholic Charities** of the Archdiocese of Galveston-Houston (Catholic Charities), providing up to an additional \$150,000.00 in Community Development Block Grant (CDBG) funds to provide case management and employment services to 150 unduplicated LMI Houstonians. (All Districts)
- c. HCD recommends Council approval of an Ordinance authorizing a First Amendment to the Subrecipient Agreement between the City and **Wesley Community Center, Inc.** of Texas (Wesley) to: (1) extend the term of the Agreement, and (2) provide up to an additional \$125,000.00 in CDBG funds for an Early Childhood Education and Out of School Time program for LMI families. (District H)
- d. HCD recommends Council approval of an Ordinance authorizing a Second Amendment to the Subrecipient Agreement between the City and **Wesley Community Center, Inc.** of Texas (Wesley), providing up to an additional \$250,000.00 in CDBG funds to provide case management and employment services to 225 unduplicated LMI Houstonians. (District H)
- e. HCD recommends Council approval of an Ordinance authorizing a Subrecipient Agreement between the City and **El Centro de Corazon** (El Centro), providing up to \$1,500,001.00 in HOPWA funds to provide Tenant Based Rental Assistance (TBRA) and supportive services for 93 very low-income households living with HIV/AIDS. (All Districts)

f. HCD recommends Council approval of an Ordinance authorizing a Second Amendment to the Subrecipient Agreement between the City and **The Women's Home**, extending the contract term and allocating up to an additional \$250,000.00 in CDBG funds to support the administration and operation of supportive services for 480 additional unduplicated homeless and LMI Houstonians. (District A)
