- The Housing and Community Development Department (HCD) recommends Council approval of an Ordinance authorizing a First Amendment to the Subrecipient Agreement between the City of Houston (City) and the Coalition for the Homeless of Houston/Harris County (Coalition), providing up to an additional \$1,076,763.00 of funds comprised of FY2026 Homeless Housing and Services Program (HHSP) General Set-Aside funds and Tax Increment Reinvestment Zone (TIRZ 2409) Affordable Housing funds to continue the administration and operation of the Housing Navigation Center located at 2903 Jensen Drive, Houston, Texas 77026. The Housing and Community Development Department (HCD) recommends Council approval of an Ordinance authorizing a Second Amendment to the Subrecipient Agreement between the City of Houston (City) and Houston's Capital Investing in Development and Employment of Adults (Capital IDEA), providing an additional \$250,000.00 in Community Development Block Grant (CDBG) funds for the continued administration and operation of a workforce development, case management, and career placement and retention program for a minimum of 110 low-to-moderate income adults residing in the City of Houston. (All Districts)
- d. The Housing and Community Development Department (HCD) recommends Council approval of an Ordinance authorizing a First Amendment to the Subrecipient Agreement between the City of Houston (City) and Northwest Assistance Ministries (NAM), to de-obligate \$83,912.15 in HOME Investment Partnerships Program – American Rescue Plan (HOME-ARP) funds allocated for Administration costs and provide \$83,912.15 in End Street Homelessness Fund (Fund 2012) funding for Administration costs to continue operating a program that will serve approximately 65 households annually who are at-risk for or experiencing homelessness.
