

## Public Notice

The City of Houston (City), through its Housing and Community Development Department (HCDD) is proposing a Substantial Amendment to the Community Development Block Grant – Disaster Recovery 2021 Winter Storm (CDBG-DR 21) budget.

In accordance with the United States Department of Housing and Urban Development's (HUD) regulations and the Citizen Participation Plan for the Community Development Grant - Disaster Recovery 2021 Winter Storm, the City is required to amend components of its Plan for a variety of reasons, including when there is a proposed change in program benefit or eligibility criteria or when an activity is deleted from the Plan.

This Amendment will:

1. Increase the assistance amount in the Home Repair Program's Reimbursement Pathway from **\$6,000.00 to \$10,000.00**.
2. Streamline and clarify eligibility criteria for the Home Repair Program.
3. **Transfer \$550,000.00** of Community Development Block Grant – Disaster Recovery 2021 (CDBG-DR21) funds from the **Rental Housing Counseling budget line item to the Neighborhood Facilities Resilience Program budget line item**.
4. Make other minor edits throughout the Plan for clarity.

The purpose of these changes is to meet homeowners' needs, align the Winter Storm Home Repair Program with other HCDD home repair activities, and realign funds to effectively manage the CDBG-DR21 funds received from HUD.

The chart below shows the CDBG-DR21 Action Plan line-item budget changes.
