			(4)	The proposed activity must preserve the distinguishing qualities or character of the building, structure, object or site and its environment;











Existing Floor Plan and Demolition



Proposed First Floor Plan




Proposed Second Floor Plan


Proposed Front (North) Elevation




Proposed Rear (South) Elevation






