Applicants have reported receiving malicious emails that appear authentic but originate from fraudulent addresses. These emails request payment through a "settlement invoice" in exchange for plat approval. Please note: The Planning Department does not issue invoices or request payment by email. The City's IT Department is actively investigating this matter. We strongly advise applicants not to open attachments or respond to suspicious requests. If you receive an email related to your plat application that seems questionable, contact the Planning Department immediately.
