#### **CALL TO ORDER**

The meeting was called to order at 3:01 p.m. by Chair, Mr. Maverick Welsh, with a quorum present. The following Commission members noted with "P" were present during all or portions of the meeting and the members noted with "A" were absent.

#### **CHAIRMAN'S REPORT**

The Chair's report was given by Chair, Maverick Welsh. Mr. Welsh reviewed the operating procedures and Speaker Rules for the audience. He also mentioned applications are due 22 days in advance of the monthly HAHC meeting. The HAHC will not accept new material including handouts or revised plans at today's meeting. Submitting new documents at the meeting may cause your application to be deferred another month. Mr. Welsh also announced the meeting was airing live on HTV and asked everyone to speak into the microphone so they could be heard. Lastly, he encouraged each Commissioner to participate in each vote and to make motions to help move the meeting along. Mr. Welsh encouraged each Commissioner to participate in each vote, reserve abstentions when there is a conflict of interest and to ensure microphones are turned on when speaking.

#### **DIRECTOR'S REPORT**

The Director's report was given by Deputy Director, Margaret Wallace Brown. Mrs. Wallace Brown reported on HAHC appeal updates. The Historic Preservation Appeals board heard one appeal last month and voted to uphold the HAHC decision. Mrs. Wallace Brown also mentioned another appeal in which the Board voted to uphold the decision of the HAHC. The owner has chosen to appeal the Board's decision before City Council. Lastly, she also mentioned that Marty Stein is the new Chair of the Houston Planning Commission.

## C. PUBLIC HEARING AND CONSIDERATION OF A LANDMARK DESIGNATION APPLICATION FOR THE PEACOCK AND PLAZA COURT APARTMENTS AT 1414-1416 AUSTIN STREET

The Chair opened and closed the public hearing. There were no speakers.

Motion made by Commissioner Archer, seconded by Commissioner Collum that the Houston Archaeological and Historical Commission recommend to City Council the Landmark Designation of the Peacock and Plaza Court Apartments at 1414-1416 Austin Street. Motion carried unanimously.

#### D. COMMENTS FROM THE PUBLIC AND THE HAHC:

Lucas Brown, the owner of 424 Euclid (agenda item A-8) asked the Commission for feedback on the design of his property and inquired about the requested encroachment.

Brooke Brown, the owner of 424 Euclid (agenda item A-8) also commented on the property and the requested encroachment.

Jerry Hooker, owner of 6 Courtlandt (agenda item A-2), thanked the commission for granting him a Certificate of Appropriateness.

Brittany Orlando sought direction from the Commission on an issue pertaining to her recently purchased home. She reported a notice was placed on her door stating the "project deviated from approved scope." Mrs. Orlando also stated the seller did not disclose of any known issues prior to selling the property.

Commissioner Hellyer announced that the AIA Sand Castle in Galveston was rescheduled for Aug 20, 2016. He also inquired about the approval of the High First Ward Historic District Design Guidelines. Deputy Director Margaret Wallace Brown stated that the project was halted during the code amendment process last year.

Omar Izfar announced this would be his last HAHC meeting after nine years of service.

Bucek inquired about Certificates of Appropriateness (COA) applications that were administratively approved. Staff reported that for the month of June roughly13 COA's were administratively approved.

ADJOURNMENT: There being no further business brought before the commission, Chair, Mr. Maverick Welsh, adjourned the meeting at 5:06 p.m. Motion was made by Commissioner Bucek and seconded by Commissioner Garcia-Herreros. Motion Carried unanimously.
