ENROLLMENT PERIOD

HPD Auto Dealers Detail will hold an open enrollment period from the first day of February to the first day of May of each year (“open enrollment period”) for heavy-duty tow operators that wish to participate in non-consent Heavy-Duty Towing and Recovery within the city limits of Houston. Heavy-duty tow operators must meet the following requirements to qualify for a HD PATSA. Tow operators that do not apply or qualify during the open enrollment period or that wish to apply after the open enrollment period can do so at the next available open enrollment period.

MINIMUM EXPERIENCE

Tow operator shall have a minimum of 5 consecutive years of incident management experience in a licensed Heavy-Duty Towing and Recovery business.
